What is the Inglewood Oil Field?

The Inglewood Oil Field covers 1,000 acres in the Baldwin Hills, producing oil and gas to meet California's growing energy needs and is approaching 100 years in operation. Nearly 80 men and women are employed full-time at the field. They work alongside another 100 to 150 contractors who support our operations.

Current operations

The Inglewood Oil Field is the largest of Los Angeles Basin's remaining producing fields. More than 430 wells are in production, bringing forth an approximate 5,590 barrels of oil each day.¹ Our current operations consist of routine well and facility maintenance as well as ongoing well abandonment.

Currently things in the field are relatively quiet with no drilling/re-drilling taking place nor are any such activities planned for the remainder of 2017.

Sentinel Peak Resources California assumed ownership on December 30, 2016. California oil and gas production is our focus and the Inglewood Oil Field is among our largest and more productive assets. With 250 employees, we rank as the state's 4th largest oil producer.

Plans for 2018

No new wells have been drilled since 2014 both as a consequence of low oil pricing and pending the outcome of a detailed reservoir assessment that is now underway. No new wells are anticipated to be drilled/re-drilled in the coming year, although we annually provide a list of the more likely well candidates should conditions change during the course of the year.

Re-working some existing wells is scheduled throughout the year to maintain production along with other repair and maintenance activities. Currently, no major work is planned in 2018 for tankage or other supporting facilities. Also, 13 wells are slated for plugging and abandonment in 2018.

No conditional use permits were applied for nor granted in 2017 and it is not anticipated that any will be applied for in 2018.

In other plans, landscaping along La Cienega Blvd was completed in 2016 and the Fairfax Ave corridor planting is underway now. Stocker St is next. You may also notice that work is underway on the Park to Playa Trail by others. This community access path goes through the Inglewood Oil Field property.

Isn't part of the field in Culver City?

Less than 10% of the field extends into Culver City. The remainder is unincorporated acreage which is governed under the Baldwin Hills Community Standards District. In effect, the field as a whole operates under the Baldwin Hills CSD provisions.

How can I learn more?

Come to the annual meeting as noted on the previous page. Also, we work closely with Los Angeles County staff in regular reporting on activities in the oil field.
