About the Inglewood Oil Field

Sentinel Peak's historic Inglewood Oil Field spans 1,060 acres within Baldwin Hills. The field has been operational since 1924, providing essential oil and gas to fulfill California's steady energy demands.

Sentinel Peak currently employs 48 dedicated individuals full-time, both in the field and office locations. Additionally, around 75 contractors contribute to the daily operations around the field. Here at the Inglewood Oil Field, we take pride in nurturing a culture that places safety, community, and environmental stewardship at the heart of our operations.

Current Operations

The Inglewood Oil Field stands as the largest among the remaining productive urban fields in the Los Angeles Basin, with over 400 active producing wells. It yields an average of 4,027 barrels of oil and 2.2 MMCF of natural gas daily. Current operations encompass regular well and facility maintenance, an ongoing well abandonment initiative, and a retired equipment removal strategy. There is no hydraulic fracturing in the Inglewood Field. This year, a total of twelve wells were slated for plugging and abandonment; as of September 15th, nine wells have been completed. There were no drilling or re-drilling activities in 2022. On the regulatory front, CalGEM completed their yearly well inspections from April to June without issuing any Notices of Violation. Additionally, our annual tabletop spill drill received commendable ratings from our Office of Spill Prevention and Response representative.



Plans for 2024

No new well drilling is scheduled for 2024. It is worth noting that we have not drilled any new wells in our field since 2014. We do, however, compile a list of potential new well candidates annually in case circumstances or permitting plans change. As in previous years, our operation focuses on production upkeep, involving the reworking of existing wells.

Notably, there are no significant projects planned in 2024 for new tanks or related facility equipment. As part of our ongoing efforts to ensure the efficiency and safety of our field, we have scheduled twelve well plugging and abandonments for 2024.
