About the Inglewood Oil Field

The Inglewood Oil Field is operated by Sentinel Peak Resources (SPR) and has been a part of the Baldwin Hills community for over 100 years. Spanning 1,060 acres, it is one of California's oldest and most historically significant oil fields, providing reliable energy since 1924. There are currently 42 full-time employees who work both in the field and in our local offices. In addition to our team, we partner with skilled contractors who help keep daily operations running safely and smoothly. SPR is driven by a strong commitment to safety, environmental responsibility, and community. We are proud to be a part of this community and are dedicated to operating in a way that respects both the people and the environment around us.

Current Operations

The Inglewood Oil Field is the largest active urban oil field in the Los Angeles Basin, producing approximately 3,100 barrels of oil and 1,900 MCF of natural gas per day. Ongoing operations include routine maintenance, well abandonments, and the removal of outdated equipment. Twelve wells are scheduled for plugging and abandonment this year. No hydraulic fracturing is conducted at the site, and there were no drilling or re-drilling activities in 2025. In keeping with our safety and environmental initiatives, our annual tabletop spill drill received commendable ratings from our Office of Spill Prevention and Response Representative.

Plans for 2027

No new well drilling is planned for 2027. Instead, our operations will continue to focus on maintaining and optimizing production through reworking existing wells. This approach allows us to efficiently manage resources while minimizing surface impact. Additionally, there are no major facility expansions, or new tank installations scheduled for the year. As part of our ongoing commitment to environmental responsibility and long-term field management, twelve wells are scheduled to be plugged and abandoned in 2027.
